The original text:

The total budget of the Programme under Priority axis 1 and Priority axis 2 for the 2010-2011 programming period is **8 741 808 Euro**, of which **7 430 536. 80 Euro** is Community funding (EU contribution). The remaining **1 311 271.20 Euro** are national contributions from the partnering countries.

Please note that the Programme financial allocation is neither broken down by each partner country nor by eligible region.
